Yearly memberships are \$25.00/active; \$20/senior; \$40/family; and \$50/contributing. A membership renewal envelope is enclosed for your convenience. If you are not a current member, please add your membership fee to your deposit check.

**Cancellation policy:** Refunds, less \$75 registration fee, will be issued prior to February 15, 2006 if a replacement can be found. Cancellation fee, after full payment, and up to March 15, will be \$150 if a replacement can be found. Cancellation after March 15 will result in complete loss of payment.

**Cancellation, trip interruption, baggage and health insurance are strongly recommended.** If there are health concerns, please be advised that payment of insurance coverage is typically required within seven to fourteen days of trip deposit to protect your coverage for pre-existing medical conditions. For the 2004 garden trip, AAA had the most reasonably priced policy. AAA membership was not required in 2004 to qualify for insurance.

**Tour Travel Policy:** The Detroit Garden Center, Inc.; World of Travel; Hampton Inn Savannah, Historic District, Excursions, Unlimited; and guide Sue Rendeiro, act only as agents for the traveling group with respect to transportation, hotels, and services. The Detroit Garden Center exercises every care possible, but can assume no liability for injury, damage, loss, accident, cancellation, or delay with the services of any airplane or motor coach engaged to carry out this tour, or for the acts of any company or person engaged in carrying out the tour due to delay or changes in air or other services, or any other causes beyond our control. All such losses or expenses must be borne by the passenger, as tour rates provide for arrangements only for the time period stated. We reserve the right to cancel any tour prior to departure, in which case, the entire payment, except for any forfeited advance deposits made on behalf of the group will be refunded without further obligation on our part.
